ORDER DIRECTING RESPONSE

The Commission’s Staff filed this complaint against KCP&L Greater Missouri Operations Company (GMO) on July 13, 2015. Staff alleges GMO failed to provide the appropriate avoided cost information to its independent evaluation, measurement and verification contractors for calculation of GMO’s Program Year 2014 annual net shared benefits for use in determining the company’s performance incentive award for Program Year 2013 through Program Year 2015. At the request of the parties, the Commission held this complaint in abeyance until a similar Staff complaint against Ameren Missouri was resolved on appeal.¹ In particular, the Commission ordered GMO to “hold any amounts collected as a performance incentive while the appeal is pending as interim, subject to refund, including interest until the Commission reaches a decision in this case.”

On July 3, 2018, the Missouri Supreme Court issued an opinion vacating the Commission's decision that favored Staff on that complaint.² The decision of the Supreme Court is now final.

The Commission will direct the parties to explain what steps should now be taken to resolve this complaint.

THE COMMISSION ORDERS THAT:

1. No later than September 17, 2018, the parties, either collectively, or individually, shall file a pleading explaining what steps the Commission should take to resolve this complaint.

2. This order shall be effective when issued.
