ORDER ALLOWING THE PRODUCTION OF CONFIDENTIAL INFORMATION TO A THIRD PARTY

On June 5, 2018, Complainant asked the Commission to allow him to show another Empire customer specific confidential information about them, for the purpose of obtaining the customer's response to the information. The Empire District Electric Company and the Commission's Staff responded, as ordered, to that request. The rule regarding customer specific confidential information was not crafted with the purpose of preventing a customer from viewing information about themselves. The Commission will grant Complainant's request with the understanding (as Staff's response observes) that just because information is discoverable, does not necessarily mean it is admissible at a hearing or other proceeding.

THE COMMISSION ORDERS THAT:

1. William Gehrs may show confidential information about a particular customer, to said customer.

2. This order shall be effective when issued.
