Surayya Ibrahim ("Complainant") filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri ("Respondent") disputing the transfer of \$1,866.24 from another address to her current residential account. Ameren Missouri filed an Answer and the Commission conducted a prehearing conference on December 20, 2017. Complainant did not participate in the prehearing conference.

On December 26, 2017, Complainant's Dismissal with Prejudice was filed with the Commission. The filing states that Ameren Missouri and Complainant reached an agreement which resolves their dispute and that the Complainant dismisses the Complaint. Pursuant to Commission Rule 4 CSR 240-2.116(1), a complainant may voluntarily dismiss a complaint without an order of the Commission at any time before prepared testimony has been filed or oral evidence offered by filing a notice of dismissal with the Commission.

Although a transcript from the December 20, 2017 prehearing conference was entered into the Commission's Electronic Filing and Information System on December 29, 2017, no oral evidence was offered at the prehearing conference. At the time that Complainant's Dismissal with Prejudice was filed, no prepared testimony or oral evidence was offered. The Commission will therefore acknowledge the dismissal by Complainant and will close this file.
