**ORDER DIRECTING NOTICE AND SETTING DEADLINES FOR FILING**  
**INTERVENTION AND HEARING REQUESTS**

On December 27, 2007, Kansas City Power & Light Company ("KCPL") applied for permission to increase from \$635 million to \$1.4 billion the authorization to issue debt securities granted by the Commission in Case No. EF-2005-0498. KCPL further requested that the Commission issue an order granting its request by March 1, 2008.

On January 23, 2008, Praxair, Inc. filed an application to intervene in this case. Based upon issues raised by Praxair that relate to KCPL's last rate case, Case No. ER-2007-0291, the Commission believes other parties to that case might have an interest in this case. Accordingly, the Commission finds that all parties of record in Commission Case No. ER-2007-0291 should be provided with notice of the application and afforded an opportunity to intervene. A date for intervention of proper parties should also be set.

The Commission's Staff is required to file either a recommendation or status report no later than February 1, 2008. The Commission shall also set a deadline for parties or prospective parties to respond to that recommendation.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party, the Commission's Staff

or the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary and make a decision based on the verified pleadings. The Commission shall also set a deadline for parties or prospective parties to request a hearing in this case.

**IT IS ORDERED THAT:**

1. The Missouri Public Service Commission's Data Center shall mail a copy of this notice to all parties of record in Case No. ER-2007-0291.

2. Any proper person wishing to intervene in this matter shall file an application to do so no later than February 7, 2008. Such applications shall be filed with:

3. Objections to an application to intervene filed after January 23, 2008, shall be filed no more than five days from the filing date of that application.

4. Any proper party or entity with a pending application to intervene wishing to respond to any Staff recommendation or status report, currently due on February 1, 2008, or request a hearing in this case shall do so no later than February 13, 2008.

5. This order shall become effective on January 24, 2008.
