# MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE AUTHORITY AND ACCOMPANYING TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves that the Commission open a case and cancel the certificate of service authority it has granted to Buzz Telecom, Corporation, to provide intrastate interexchange telecommunications services in Missouri, as well as its tariff. In support of its Motion, Staff respectfully states as follows:

- 1. On February 23, 2003, the Missouri Public Service Commission (Commission) issued an order granting a certificate of service authority to provide intrastate interexchange telecommunications services to Buzz Telecom, Corporation in Case No. XA-2003-0231, and approved its tariff, P.S.C. Mo. No. 1, in the same case.
- 2. Buzz Telecom, Corporation, through correspondence from its president, has asked the Commission to cancel its certificate of service authority because it has no customers using the service that was to be provided under that name, and does not intend to pursue that line of business. See Appendix A.
- 3. The web site of the Office of the Missouri Secretary of State reports that the authority of Buzz Telecom, Corporation, a Nevada corporation, to do business in Missouri was revoked on March 29, 2006 because the company failed to file its Annual Registration Report. Section 351.602.3 RSMo. (2000) states that "[t]he authority of a foreign corporation to transact business in this state ceases on the date shown on the certificate revoking its certificate of authority."

- 4. No complaints have been filed against the company since the commencement of the Electronic Filing and Information System.
- 5. Because Buzz Telecom, Corporation has requested cancellation of its certificate, because it is no longer authorized to do business in Missouri, and because it is not providing telecommunications service, the Staff recommends that the Commission issue an order canceling Buzz Telecom, Corporation's certificate of service authority, as well as its tariff.
- 6. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 2006), which provides:

"Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo.App. 1989).

7. This pleading is being served on the address provided most recently by the company to the Commission via certified mail, as well as the address previously provided to the Commission and upon its Missouri registered agent.

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority of Buzz Telecom, Corporation to provide intrastate interexchange telecommunications services; and also its tariff, P.S.C. Mo. No. 1.
