Thank you for submitting your 2008 Annual Report to the Missouri Public Service Commission. As a result of my review, I have identified the following items that need to be corrected:

1. On pages 5a and 5b, related to your CLEC operations, you are required to include one of the following on each page:
  - a) Zeros in all columns on the Totals line.
  - b) Actual Exchange descriptions and counts.
  - c) A statement indicating that your company does not have any exchanges.

You may choose any of the above options based on your company's specific situation for each page. Please note that N/A is not an acceptable response. If you have any questions regarding this, please contact me.

A response for this item is required in order to show your report as complete and remove it from deficiency status.

You **must resubmit** the annual report with the appropriate changes and the reference number below for it to be properly entered into the system.

Your prompt attention to resolving this matter is appreciated. The Commission's rule 4 CSR 240-3.540 (4) states that a utility company which receives a notice of deficiency for the information provided in the annual report shall respond to that notice within **20 days**, or the utility company is subject to a **penalty of \$100** for each day that it is late in filing its response to the deficiency.
