**NOTICE OF COMPLAINT, ORDER ESTABLISHING TIME TO RESPOND  
AND ORDER ESTABLISHING TIME TO APPLY TO INTERVENE**

Issue Date: February 13, 2014

Effective Date February 13, 2014

On February 12, 2014, Noranda Aluminum, Inc. and 37 other individual customers of Ameren Missouri filed a complaint with the Missouri Public Service Commission against Union Electric Company, d/b/a Ameren Missouri, alleging that Ameren Missouri is earning money at an excessive rate. The complaint asks the Commission to review Ameren Missouri's rates and to revise those rates to just and reasonable levels. Pursuant to Commission Rule 4 CSR 240-2.070, Ameren Missouri has thirty days from the date of this notice to file an answer. Since this notice is being issued on February 13, the thirty-day period will expire on Saturday March 15. That means Ameren Missouri's answer is due no later than Monday, March 17, 2014.

Since this complaint will likely draw the interest of potential intervenors, the Commission will also establish a date for the filing of applications to intervene. That date will be set ten days before Ameren Missouri's answer is due so that responses to those applications to intervene can be filed at the same time as Ameren Missouri's answer.

As required by Section 536.067(2)(f), RSMo 2000, the Commission informs the parties that the Commission's provisions governing procedures before the Commission, including provisions relating to discovery, are found at Commission Rule 4 CSR 240-2.090.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall send, by certified mail, a copy of this notice and order and a copy of the complaint to Union Electric Company, d/b/a Ameren Missouri at:

2. Union Electric Company, d/b/a Ameren Missouri shall file its answer to this complaint no later than March 17, 2014. All pleadings shall be mailed to:

or shall be filed using the Commission's electronic filing and information service.

3. Any party wishing to intervene in this case shall apply to intervene no later than March 7, 2014.

4. Any person or entity wishing to respond to any application to intervene shall do so no later than March 17, 2014.

5. This order shall become effective upon issuance.
