ORDER AMENDING PROCEDURAL SCHEDULE

On August 30, 2017, the Commission issued an *Order Setting Procedural Schedule and Other Procedural Requirements*, which set an evidentiary hearing for September 26, 2017 and briefs for October 12, 2017. On September 25, 2017, the Commission granted Ameren Missouri's motion for continuance and postponed the evidentiary hearing. The Commission will now set a new date for the evidentiary hearing and adjust the deadline for briefs.

THE COMMISSION ORDERS THAT:

1. The evidentiary hearing is scheduled for Thursday October 12, 2017, beginning at 9:00 a.m. The hearing will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Any person requiring additional accommodations to participate in the hearing shall call the

2. Mr. Fisher may appear and participate in the evidentiary hearing by videoconference from the Commission's St. Louis office in the Wainwright State Office Building, 111 North 7th St., Suite 105, St. Louis, Missouri 63101.

3. The deadline for filing briefs is extended until no later than October 31, 2017.

4. All other provisions of the Commission's *Order Setting Procedural Schedule and Other Procedural Requirements* shall remain in effect.

5. This order shall be effective when issued.
