ORDER GRANTING REQUEST FOR MEDIATION AND SUSPENDING SCHEDULE

Issue Date: October 24, 2017

The Commission is granting the *Request for Mediation and Motion for Stay or Extension of Time to File Answer*¹ (“motion”). Union Electric Company d/b/a Ameren Missouri filed the motion. Anita Wessling agrees to mediation² and Staff does not object.³ Therefore, the Commission will grant the motion.

Pending mediation, the Commission’s regulations provide a suspension of the procedural schedule:

All other actions on the case shall cease and all time limitations shall be tolled pending the completion of mediation process, except as otherwise provided by law.⁴

Therefore, the deadlines provided by regulation or order are tolled pending mediation.

The Commission will appoint a mediator by separate order.
