On October 31, 2017, Anthony Granillo (“Complainant”) filed a complaint against Union Electric Company, d/b/a Ameren Missouri (“Ameren Missouri”). At the January 8, 2018, prehearing conference Mr. Granillo requested mediation. Ameren Missouri consented, but asked to respond to Staff’s report prior to mediation, which was granted. Ameren Missouri filed a response to Staff’s report on March 5, 2018.
