Thank you for submitting your 2007 Annual Report to the Missouri Public Service Commission. I have reviewed your report and have found the following omissions / errors:

1. Your response to page 1, question 4, part a, was incorrect. The latest effective date is **11/1/07** instead of 5/22/03 as submitted. Please include this information on any future submissions.
2. Your response to page 1, question 4, part b, was incorrect. The latest case number is **TN-2008-0048** instead of CA-2003-0303 as submitted. Please include this information on any future submissions.
3. When filing your annual report please remember to use the most current form available. The forms can be found on the PSC website at www.psc.mo.gov under forms.

The Commission's Data Center recognizes that "the certification date and case number shall be that of the original certification unless a name change, entity change (Corp. to LLC, etc.) or merger/sale has occurred. In those instances, the effective date and case number shall be that of the latest case on file for one of these occurrences." The effective date can be found at the end of the order for the case and is not the date of the order itself.

This company has changed its name from Cinergy Communications Company to Norlight, Inc. effective 11/1/07, case number TN-2008-0048.
