**ORDER APPROVING TARIFF SHEETS FILED IN COMPLIANCE**  
**WITH COMMISSION'S ORDER**

Issue Date: August 22, 2007

Effective Date: September 4, 2007

This order approves the tariff sheets filed in compliance with a Missouri Public Service Commission order by Aquila, Inc., d/b/a Aquila Networks-MPS.

In its Report and Order issued in this case on July 3, 2007, the Missouri Public Service Commission approved the Territorial Agreement executed on the February 28, 2007, between Aquila, Inc., d/b/a Aquila Networks-MPS ("Aquila") and Platte-Clay Electric Cooperative, Inc. ("Platte-Clay") (the "Territorial Agreement"). The July 3, 2007 Report and Order also ordered Aquila to file revised tariff sheets to include maps and legal descriptions of the exclusive territories Aquila obtained from the Territorial Agreement.

On August 3, 2007, Aquila filed in this case three (3) tariff sheets bearing a proposed effective date of September, 4, 2007. Those tariff sheets were assigned Tariff No. YE-2008-0092. The tariff sheets revise Aquila's Description of Service Territory by identifying, with maps and legal descriptions, the boundaries of the exclusive territories agreed to in the Territorial Agreement.

On August 22, 2007, the Commission's Staff filed a verified recommendation. Staff states that it has reviewed Tariff No. YE-2008-0092 and is of the opinion that it is in compliance with the Commission's July 3, 2007 Report and Order. Staff recommends that the Commission approve the proposed tariff sheets to become effective on September 4, 2007.

The Commission has reviewed Aquila's tariff sheets and Staff's verified recommendation, which are hereby admitted into evidence. Based on these filings, the Commission finds that the tariff sheets shall be approved.

**IT IS ORDERED THAT:**

1. Tariff No. YE-2008-0092, submitted on August 3, 2007, is hereby approved for electric service rendered on or after September 4, 2007. The tariff sheets approved are:
