**JOINT PROCEDURAL SCHEDULE PROPOSAL AND

2. On November 4, 2019, the Commission issued an Order Granting Intervention and Setting Prehearing Conference (“Order”), in which the Commission set a prehearing conference for November 20, 2019. Since the Parties have agreed upon a proposed procedural schedule, which includes a date for a proposed settlement conference, the Parties request that the Commission issue an order cancelling the November 20 prehearing.

**WHEREFORE**, the Parties request the Commission issue an order adopting the procedural schedule set forth above and cancelling the prehearing conference set for November 20, 2019.
