STAFF'S RECOMMENDATIONS REGARDING UNION ELECTRIC COMPANY D/B/A AMEREN MISSOURI'S REQUESTED VARIANCES AND TARIFF FILING

COMES NOW the Staff of the Public Service Commission of the State of Missouri and states to the Commission the following regarding the tariff sheets filed by Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") on June 5, 2019, and substituted on June 13, 2019:

- 1. On June 5, 2019 Ameren Missouri filed a request for variance from Commission rule 4 CSR 240-13.020(6) ("Request for Variance"), along with five proposed tariff sheets. Ameren Missouri also seeks relief from the 60-day notice requirement of 4 CSR 240-4.017.¹ On June 6, 2019, the Commission ordered Staff to file its Recommendation no later than June 20, 2019. On June 13, 2019, Ameren Missouri filed a substitute tariff sheet, MO.P.S.C. Schedule No. 6 4th Revised Sheet No. 95.1, to correct a typo in the tariff sheet revision number.
- 2. Staff has reviewed Ameren Missouri's Request for Variance Application and submits its Recommendation in the accompanying Memorandum, which is incorporated herein by reference. As reflected in Staff's Memorandum, Staff recommends that (i) if the Commission grants Ameren Missouri a variance from 4 CSR 240-13.020(6) it also grant Ameren Missouri a variance from 4 CSR 240-13.015(1)(C); and (ii) if the Commission

grants Ameren Missouri a variance from 4 CSR 240-13.020(6) and 4 CSR 240-13.15(1)(C), the Commission issue an order rejecting the tariff sheets filed on June 5, 2019, and as substituted on June 13, 2019, in Case No. EE-2019-0385 and Tariff Tracking No. YE-2019-0217, and order Ameren Missouri to re-file the same five tariff sheets listed below² with the addition of language reflecting the approved variances from Chapter 13.

DATE: June 20, 2019

Overview

On June 5, 2019, Ameren Missouri ("Ameren Missouri" or "Company") filed a notice of case filing and request for variance along with tariff revisions. Ameren Missouri requested a variance from Commission rule 4 CSR 240-4.017 to waive the 60-day notice of case filing. Ameren Missouri also requested a variance from 4 CSR 240-13.020(6) which requires utilities to provide notification to affected customers when adjustments are made to billing cycles which result in a change of nine (9) days or more. Along with the request for variance, Ameren Missouri filed five revised tariff sheets that would implement the "Pick Your Due Date" option for customers.

On June 6, 2019, the Commission issued <u>ORDER ESTABLISHING TIME FOR STAFF TO FILE A RECOMMENDATION ordering Staff to file a recommendation</u> regarding the request for variance and implementing tariff changes, and allowing responses to Ameren Missouri's request from any party, by June 20, 2019. No parties have responded to date.

On June 13, 2019, Ameren Missouri filed a substitute Table of Contents, MO.P.S.C. Schedule No. 6 4th Revised Sheet No. 95.1 to correct a typo in the tariff sheet revision number.

Staff Findings

Ameren Missouri's proposed "Pick Your Due Date" program is a voluntary opt-in program for customers who are not satisfied with the standard billing cycle they are currently served on. A similar program is already available to customers who participate in the Keeping Current Low-Income Pilot Program. The "Pick Your Due Date" option would allow customers to choose the due date of their electric bills which would also result in a change in the customer's billing cycle. Due to potential time constraints and since the change is made at the customer's request,

Ameren Missouri is requesting a waiver from the notice requirement of Commission Rule 4 CSR 240-13.020(6) that states:

...If a utility changes a meter reading route or schedule which results in a change of nine (9) days or more of a billing cycle, notice shall be given to the affected customer at least fifteen (15) days prior to the date the customer receives a bill based on the new cycle.

In Staff's opinion, Ameren Missouri's proposed tariff revision conflicts with Commission Rule 4 CSR 240-13.015(1)(C), that states:

Billing period means a normal usage period of not less than twenty-six (26) nor more than thirty-five (35) days for a monthly billed customer nor more than one hundred (100) days for a quarterly billed customer, except for initial, corrected, or final bills.

In addition, Ameren Missouri filed this case without the requisite public notification of the pending case. Such notification is a requirement when requesting variances from Chapter 13 regulations, with Commission Rule 4 CSR 240-13.065(2) stating:

A utility filing an application for a variance with the commission shall mail, contemporaneously with the filing, copies of the application by first class mail to the newspaper with the largest circulation in each county within the utility's service area affected by the variance, the public counsel and each party in the utility's most recent rate case who represented residential customers.

Staff spoke with Ameren Missouri on June 17, 2019, to confirm this requirement was met. The Company had not completed the public notice at this time due to an oversight. On June 19, 2019, Ameren Missouri advised Staff that notification was emailed to the largest newspapers in each county served. While the rule states the notice is to be made by first class mail, email allowed the Company to notify the newspapers in an expedited manner.

Lastly, Commission Rule 4 CSR 240-13.065 (3) states:

Any variance granted by the commission shall be reflected in a tariff.

The tariff sheets filed in Case No. EE-2019-0385 and Tariff Tracking No. YE-2019-0217, do not reflect Ameren Missouri's requested variance from Commission Rule 4 CSR 240-13.020(6) or Commission Rule 4 CSR 240-13.015(1)(C) based on Staff's review.

Staff Recommendation

Staff recommends that Ameren Missouri submit proof of the required notifications to newspapers and parties who represented residential customers in its most recent rate case per Commission Rule 4 CSR 240-13.065(2). Further, Staff recommends that the Commission grant Ameren Missouri a variance from Commission Rule 4 CSR 240-13.020(6) and Commission Rule 4 CSR 240-13.015(1)(C).

If the Commission grants Ameren Missouri variances from Commission Rule 4 CSR 240-13.020(6) and Commission Rule 4 CSR 240-13.015(1)(C), Staff recommends that the Commission reject the tariff sheets filed on June 5, 2019, and as substituted on June 13, 2019, in Case No. EE-2019-0385 and Tariff Tracking No. YE-2019-0217, and order Ameren Missouri to file the same five tariff sheets listed below with the addition of language reflecting the approved variances from Chapter 13.
