On September 27, 2022, Union Electric Company d/b/a Ameren Missouri filed a Request for Variance, asking the Commission to grant it variances from certain requirements of the Commission's integrated resource planning rule, 20 CSR 4240-22. Specifically, Ameren Missouri seeks a variance from certain provisions of Commission Rules 20 CSR 4240-22.040, 22.045, 22.060, and 22.080.

Since the Commission's decision to grant or deny the requested variances may affect the substance of Ameren Missouri's integrated resource plan filing, the Commission will provide notice to potentially interested parties and the public, and will establish an intervention deadline. In addition, the Commission will establish a date for its Staff and other interested parties to offer recommendations regarding Ameren Missouri's request for variances.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to all parties to Ameren Missouri's current general rate proceeding, ER-2022-0337, and its most recent integrated resource plan triennial compliance filing, EO-2021-0021.

- 2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the media serving Ameren Missouri's service area and to the members of the General Assembly representing Ameren Missouri's service area.
- 3. Any proper person wishing to intervene in this matter shall file an application to do so no later than October 14, 2022.
- 4. Staff shall file its recommendation regarding Ameren Missouri's Request for Variance no later than November 3, 2022.
- 5. Any other party wishing to respond to Ameren Missouri's Request for Variance shall do so no later than November 3, 2022.
 - 6. This order shall be effective when issued.
