APPLICATION

COMES NOW Central Rivers Wastewater Utility, Inc. (Central Rivers), pursuant to 393.170, RSMo, 4 CSR 240-2.060 and 4 CSR 240-3.305 (Sewer Certificate), and, for its Application states as follows to the Missouri Public Service Commission (Commission):

BACKGROUND

1. Central Rivers is a Missouri general business corporation duly organized and existing under the laws of the State of Missouri with its principal office and place of business located at P.O. 528, Kearney, MO 64060. Attached hereto as **Appendix 1** is a Certificate of Good Standing issued by the Missouri Secretary of State related to Central Rivers. Central Rivers has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates having occurred within three years from the date of this Application. Central Rivers has no annual report or assessment fees which are currently overdue. Central Rivers provides sewer service to approximately 280 customers in Ray and Clay Counties, Missouri, pursuant to certificates of convenience and necessity previously granted in Commission Cases Nos. SA-2005-0302, SA-2004-0470, SA-2001-304, SA-2000-105, SA-2000-248 and SA-98-530. Central Rivers is a "sewer corporation" and a "public utility" as those terms are defined in Section 386.020, RSMo, and is subject to the jurisdiction and supervision of the Commission as provided by law

CERTIFICATE

3. Central Rivers requests permission, approval and a Certificate of Convenience and Necessity to construct, install, own, operate, maintain, control and manage a sewer system for the public in an area in Clinton County, Missouri, as an addition to Central Rivers' existing service territories. A map of the area sought to be certificated is attached to this Application as **Appendix 2**. A legal description of the area to be certificated is attached hereto as **Appendix 3**.

4. This area generally encompasses a development known as Country Hills Estates. No other sewer service is currently available in the subject territory.

5. There are approximately 30 residential lots being developed in the identified territory. Attached hereto as **Appendix 4** is a list of ten residents or landowners from the territory for which a certificate is sought.

6. Marked as **Appendix 5A and 5B**, attached hereto, and made a part hereof for all purposes, is a feasibility study and engineering report for the sewer system.

7. Central Rivers proposes to use its rates and charges currently on file and approved by the Commission for service in its existing certificated territories.


8. Central Rivers proposes to use the general terms and conditions of service found in its Commission-approved tariff to govern its provision of sewer service to this territory.

9. The subject territory is not within the boundaries of an incorporated municipality. Central Rivers is not aware of any franchise (either city or county) that would be required in order for it to provide service in this territory. A permit for the operation of this facility has been issued by the Missouri Department of Natural Resources (DNR), a copy of which is attached hereto as **Appendix 6**. Central Rivers is not aware of any other governmental approval that it must obtain.

10. The territory Central Rivers proposes to certificate has a need for an operating sewer system and otherwise has no sewer service available. Central Rivers' experience in the operation of sewer systems gives it the ability to provide this service in an efficient manner. For these reasons, a grant of the application will further the public convenience and necessity.

WHEREFORE, Central Rivers requests the Commission grant it permission, approval and a Certificate of Convenience and Necessity authorizing it to construct, install, own, operate, maintain, control and manage a sewer system for the public within the area referred to above, and to issue such other orders as the Commission may deem appropriate.



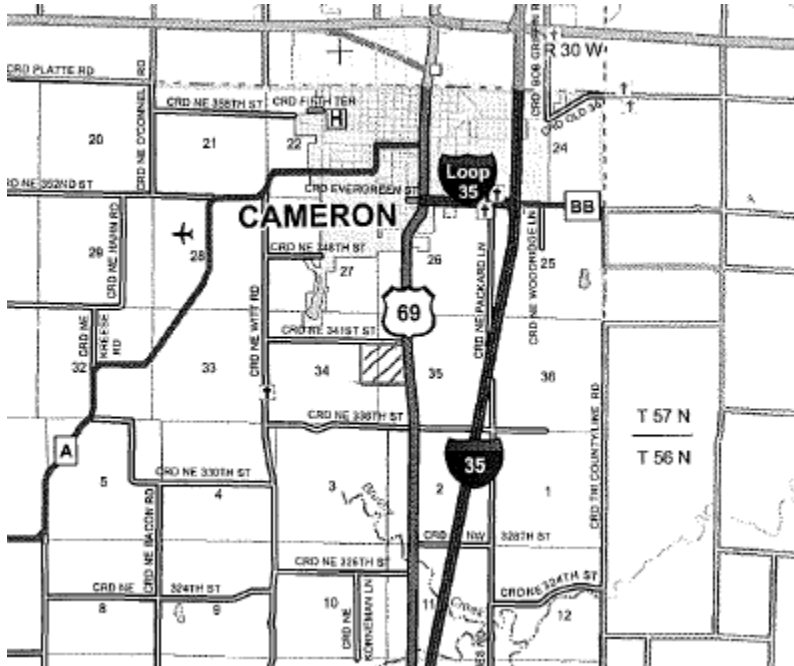

Country Hills Estates service area description

This service area in Clinton County, Missouri approximately a mile south of Cameron, Missouri. Located in Sections 34 and 35 Township 57 North, Range 30 West and containing approximately 180 acres.

Generally described as:

Having a North boundary of the NE 341 Street,
an East boundary of Missouri Highway 69,
a South boundary of the south line(extended) of the north half of the southwest quarter of Section 35, and a West boundary of west line(extended) of northeast quarter of the southeast quarter of Section 34.

Specifically described as:

The Point of Beginning is the intersection of the centerline of U.S. Highway 69 and the south line of the north half of the southwest quarter of section 35, township 57 north, range 30 west; thence west along the south line of said north half of the southwest quarter of section 35 and continuing along the south line of the north half of the southeast quarter of section 34, township 57 north, range 30 west approximately 2,940 feet to the southwest corner of the northeast quarter of the southeast quarter of Section 34, township 57 north, range 30 west; thence north along the quarter quarter section line approximately 2,700 feet to the centerline of NE 341 Street; thence east along the centerline of said NE 341 Street approximately 2,800 feet to centerline of U.S. Highway 69; thence South along the centerline of U.S. Highway 69 approximately 2,700 feet to the south line of the north half of the southwest quarter of Section 35 and the point of beginning.
