STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. Broadwing Communications, LLC (Broadwing) currently has two Missouri No. 1 tariffs -- one that applies to interexchange telecommunications service and one that applies to local, message toll, and long-distance end-user communications services.

2. The Commission ordered Broadwing to file new tariff sheets to provide local, message toll and long-distance end-user communication service.

3. Broadwing submitted a new Missouri No. 3 tariff to apply to those services.

4. In the attached Memorandum, labeled Appendix A, the Staff recommends approval of Broadwing's Missouri No. 3 tariff.

WHEREFORE, the Staff recommends the Commission approve Broadwing's P.S.C. MO. Tariff No. 3 and cancel Broadwing's P.S.C. MO Tariff No. 1 applying to local, message toll, and long-distance end-user communications services, effective June 27, 2005.

On April 13, 2005, in Case No. CT-2005-0291, the Commission ordered Broadwing Communications, LLC (Broadwing), a competitive local exchange and interexchange telecommunications carrier to file new tariff sheets to provide local, message toll, and long-distance end-user communications services that will distinguish that tariff from its interexchange tariff No. 1, Tariff No. JX-2004-0199. Currently, Broadwing has two Missouri No. 1 tariffs.

On May 13, 2005, Broadwing, filed P.S.C. MO Tariff No. 3 to provide local, message toll, and long-distance end-user communications services. Broadwing was granted a certificate to provide local exchange telecommunications service in Case No. CT-2005-0291.
