**ORDER SCHEDULING A PREHEARING CONFERENCE  
AND FURTHER SUSPENDING TARIFF**

On March 21, 2006, Sage Telecom, Inc. filed a proposed tariff designed to implement a Switched Network Recovery Charge.

On March 28, 2006, the Office of the Public Counsel filed a Motion to Reject Tariff or, in the Alternative, to Suspend Tariff.

On March 30, 2006, the Commission issued an Order Suspending Tariff and Setting Deadline to File Response to Motion to Reject Tariff. In that order the Commission suspended the tariff for 30 days and set a deadline for parties to respond to Public Counsel's motion. Sage Telecom and Staff each filed responses to Public Counsel's motion.

Based upon the issues raised in Public Counsel's motion and the parties' responses, there appear to be questions as to whether the proposed tariff is lawful and reasonable.

The next step is to move this matter toward resolution. To that end, the Commission will conduct a prehearing conference to discuss the scheduling of an

evidentiary hearing. To allow sufficient time to schedule and conduct an evidentiary hearing the tariff will be suspended an additional ninety days.

**IT IS ORDERED THAT:**

1. A prehearing conference shall be held on May 10, 2006, beginning at 10:00 a.m., in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This conference will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.
