COME NOW CenturyTel of Missouri, LLC ("CenturyTel") and Spectra Communications Group, LLC d/b/a CenturyTel ("Spectra") (collectively referred to herein as "Applicants"), pursuant to Commission Rule 4 CSR 240-2.075 and the Commission's *Order Establishing Intervention Deadline and Requiring Filing ("Order")* issued in this matter on September 8, 2005, and respectfully submit their Joint Application to Intervene in the above-captioned case. In support of their Application, Applicants state that:

1. CenturyTel is a Louisiana limited liability corporation that is duly authorized to do business in the state of Missouri. CenturyTel is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide "telecommunications service" within the State of Missouri as each of those terms are defined in Section 386.020, RSMo. 2000. Spectra Communications Group, LLC d/b/a CenturyTel is a Delaware Limited Liability Company authorized to do business in Missouri. Spectra is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide "telecommunications service" within the State of Missouri as each of those terms are defined in Section 386.020, RSMo. 2000.

This case arose from the filing, on August 19, 2005, of a Motion to Open Case and Motion for Protective Order by the Commission's Staff, so as to provide a vehicle for the Commission to determine the average rate of nonwireless basic local telecommunications services as of August 28, 2005, pursuant to new subsection 13 to Section 392.245. By its Notice Opening Case issued on August 29, 2005, the Commission stated that "Pursuant to Senate Bill No. 237, an act relating to telecommunications companies, the Commission is to determine the average rate of nonwireless basic local telecommunications services; therefore, a new case has been opened." The Commission's September 8, 2005 Order directed that any party wishing to intervene in the case should file an application to do so by not later than September 28, 2005.
- 4. The Commission should permit CenturyTel and Spectra to intervene in this case pursuant to Commission Rule 4 CSR 240-2.075(4)(A) because CenturyTel and Spectra's interests differ from those of the general public. As local exchange

telecommunications companies, CenturyTel and Spectra are two of those companies that

have been ordered to submit to the Commission's Staff the information referred to in the

Commission's Order. No other party to this proceeding will adequately represent or

protect CenturyTel and Spectra's interests. At this point in time, CenturyTel and Spectra

are unsure of the positions they will take in this proceeding.

5. CenturyTel and Spectra's interventions would be in the public interest, in

accordance with Commission Rule 4 CSR 240-2.075(4)(B), as their participation in this

case will contribute to the implementation of new Subsection 392.245.13.

WHEREFORE, CenturyTel of Missouri, LLC and Spectra Communications

Group, LLC d/b/a CenturyTel respectfully request that the Commission grant their Joint

Application to Intervene in the above-captioned case.
