Dear Customer:

On March 27, 2013, Rogue Creek Utilities, Inc. (Company) submitted a request for increases in its annual water and sewer operating revenues to the Missouri Public Service Commission (Commission). The reasons for the increases are to cover increases in routine operation and maintenance expenses; increases in the Company's receivership-related expenses; the need to perform, and recover the cost of, several deferred maintenance items; and the need to pay, and recover the cost of, several past-due accounts payable.

By its request, the Company is seeking changes to its customer rates intended to generate an increase in its annual sewer operating revenues of \$48,565 (approximately 278%) and an increase in its annual water operating revenues of \$40,425 (approximately 254%). Set out at the end of this notice is a table that compares the Company's current customer rates and the customer rates that would result from the noted percentage increases.

In addition to the regular operating revenue increase requests, the Company also requested and has received Commission approval of the following emergency Interim Rates, which went into effect on May 31st. Prior to the Commission approving these Interim Rates, the Public Service Commission Staff (PSC Staff) and the Office of the Public Counsel (Public Counsel) agreed that they were necessary. *To provide information regarding the need for the Interim Rates, I will be attending the Rogue Creek Valley association meeting on Saturday June 29th. This meeting is being held at the RCV clubhouse and will begin at Noon. Representatives of the PSC Staff and the Public Counsel will also be attending the meeting.*

Interim Rate A Water = \$7.97/month Sewer = \$5.61/month
(these interim rates are to be in effect until the revenue increase requests are completed and are subject to refund under certain conditions)

Interim Rate B Water = \$9.89/month Sewer = \$10.18/month
(these interim rates are to be in effect thru November 30, 2013 and the monies that will be collected as a result of these rates are dedicated to specific projects)

To provide comments regarding the Company's revenue increase requests, or comments regarding service-related problems, please contact the PSC Staff and/or the Public Counsel ***within 30 days of the date of this notice***. Your comments should include a reference to file numbers SR-2013-0435 and/or WR-2013-0436. The PSC Staff and the Public Counsel will review all customer comments submitted in response to this notice. The customer comments will also be filed in the official case file so that they will be available for review by the Commissioners.
