## ORDER SHORTENING TIME TO REPLY TO STAFF'S RECOMMENDATION

On September 11, 2018, Kansas City Power & Light Company (the "Company") requested authority to issue General Mortgage Bonds up to \$1,900,000,000 principal amount during the period ending December 31, 2019. The Company also asked that the order granting its application go into effect on November 30, 2018. On September 12, 2018, the Commission directed the Staff of the Commission ("Staff") to file a recommendation on the Company's application no later than October 12, 2018. Subsequently, the Commission extended the deadline for Staff's recommendation to November 2, 2018. On November 2, 2018, Staff filed its recommendation. Therein, the Staff recommended that the Commission grant the Company's application subject to conditions. Because the Company has asked that an order granting its application go into effect on November 30, 2018, and because November 12, 2018, is a holiday, the Commission will shorten the time for the Company to reply to Staff's recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than November 9, 2018, Kansas City Power & Light Company shall file a Reply to the Recommendation of the Staff of the Missouri Public Service Commission.

2. This order shall be effective when issued.
