ORDER DIRECTING STAFF TO FILE RECOMMENDATION

Issue Date: January 5, 2023

On January 5, 2023, Union Electric Company d/b/a Ameren Missouri filed an application requesting financing authority to issue and sell up to \$500,000,000 aggregate principal amount of additional long-term indebtedness. Ameren Missouri also requested expedited treatment of its application, asking that Commission approval be effective no later than February 26, 2023.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation regarding Ameren Missouri's application. The Commission will also set a deadline for responses to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than February 1, 2023, Staff shall file a recommendation regarding Ameren Missouri's application requesting financing authority to issue and sell up to \$500,000,000 aggregate principal amount of additional long-term indebtedness.
2. Any responses to Staff's recommendation or objections to the application shall be filed no later than February 8, 2023.
3. This order shall be effective when issued.
