## NOTICE REGARDING PROCEDURAL TIMELINE

Issue Date: December 14, 2009

On August 5,<sup>1</sup> KCP&L Greater Missouri Operations Company ("GMO") filed its 2009 Integrated Resource Planning Filing ("IRP"), which is required by the Commission's Integrated Resource Planning rule, i.e., 4 CSR 240-22. Pursuant to 4 CSR 240-22.080(5) and (6), the Commission's Staff had to file a report, and Public Counsel, and any other intervenor could file a report or comments within 120 days of KCPL's IRP filing, i.e., December 3. The initial deadline for reports and comments was extended until December 10.<sup>2</sup>

On December 10, the Missouri Department of Natural Resources, Dogwood Energy, L.L.C., Public Counsel, and the Commission's Staff all filed reports alleging certain deficiencies with KCPL's IRP. Commission Rule 4 CSR 240-22.080(8) provides that the parties are now allowed 45 days to work with the utility, and each other, to prepare and submit a joint agreement on a plan to remedy the identified deficiencies. If an agreement cannot be reached, 4 CSR 240-22.080(9) provides that the utility and the other parties are allowed until the 60th day after the filing of comments to file a response to the alleged deficiencies. Because the reports and comments were filed on December 10, the deadline

for filing the joint agreement is January 25, 2010 (45 days after the reports and comments were filed),<sup>3</sup> and the deadline for a response from KCPL for any alleged unresolved deficiencies and additional comments from the other parties is February 8, 2010 (60 days after the reports and comments were filed). Any party believing it requires additional time to file its responses may file an appropriate motion requesting an extension of time pursuant to 4 CSR 240-22.080(12).
