ORDER GRANTING APPLICATIONS TO INTERVENE

On December 5, 2008, KCP&L Greater Missouri Operations Company (GMO) filed an application for waivers concerning its 2009 integrated resource plan (IRP) submission. The Commission published notice of the application and set December 29, 2008, as the filing deadline for applications to intervene. Dogwood Energy, LLC, and the Missouri Department of Natural Resources have filed timely applications to intervene. The Sedalia Industrial Energy Users' Association filed its application to intervene on December 30, 2008, one day out of time. No responses to the intervention requests have been filed.

Dogwood Energy owns a combined cycle generating facility in Pleasant Hill, Missouri, within GMO's service territory Dogwood Energy states that the Commission's decision in the case could affect its interests. Dogwood Energy further states that its intervention is in the public interest because of its expertise in the areas being investigated and its experience as a wholesale electric power provider. Dogwood takes no position on GMO's application at this time.

MDNR is a state agency vested with powers and duties as set forth in Section 640.150, RSMo. MDNR states that its interest differs from that of the general

public and that its intervention will serve a public interest in that its Energy Center will be evaluating GMO's application from a formal policy and planning perspective as well as from the perspective of potential impacts on environmental quality. MDNR filed a statement regarding its position on January 9, 2009.

SIEUA is an association of large commercial and industrial users of natural gas and electricity in Sedalia, Missouri, and the surrounding area. SIEUA states that its members are GMO customers under separate contracts or rate schedules and therefore have interests that are different from those of the general public and that cannot be represented by any other party to the case. As reason for its filing out of time, SIEUA states that initially it believed GMO's filing to be an additional waiver request concerning Kansas City Power & Light Company's pending 2008 proceeding, and that it learned too late to file a timely application that, instead, the filing may be an initiating filing for GMO's next IRP filing. SIEUA does not take a position on the waiver request at this time.

The Commission finds that the applicants have interests in this proceeding that are different from those of the general public; and that granting the interventions will serve the public interest. The Commission further finds that SIEUA's explanation for filing its application one day out of time is reasonable, and that no party will be prejudiced by granting SIEUA's application.

THE COMMISSION ORDERS THAT:

- 1. Dogwood Energy, LLC's Application to Intervene is granted.
- 2. The Missouri Department of Natural Resource Application to Intervene is granted.

- The Application to Intervene of Sedalia Industrial Energy Users' Association
 One Day Out of Time is granted.
 - 4. This order is effective upon issuance.
