ORDER PROVIDING NOTICE, ESTABLISHING INTERVENTION DEADLINE, AND SCHEDULING PROCEDURAL CONFERENCE

Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company (jointly, "Applicants") filed an application requesting a limited variance from the Commission's affiliate transaction rule in 4 CSR 240-20.015. Specifically, Applicants request a waiver from the asymmetric pricing requirements in 4 CSR 240-20.015(2) in so far as the rule would apply to an agreement reached between Applicants and Grid Assurance.

The Commission will provide notice of the application and set a deadline for intervention requests. The Commission will also schedule a procedural conference.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to all parties to the current general rate cases for Applicants in File Nos. ER-2018-0145 and ER-2018-0146.

2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the media and members of the General Assembly serving Applicants' service areas.

3. Any person wishing to intervene in this matter shall file an application no later than June 29, 2018.

4. A procedural conference shall be held on July 12, 2018, at 10:00 a.m., in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, a building that meets accessibility standards of the Americans with Disabilities Act. 5. This order shall be effective when issued.


