ORDER GRANTING INTERVENTION

Issue Date: October 5, 2018 Effective Date: October 5, 2018

On August 27, 2018, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") filed a Joint Application with the Missouri Public Service Commission, requesting that the Commission grant it variances from certain requirements of the Commission's net metering rule, 4 CSR 240-20.065. KCP&L and GMO ask the Commission to grant a variance to allow them to remove the "solar rebate application" information from their respective Net Metering Tariffs.

On September 14, 2018, the Missouri Industrial Energy Consumers ("MIEC") filed an application to intervene. MIEC is a non-profit corporation representing the interests of large industrial customers of KCPL and GMO. MIEC has an interest that is different from that of the general public in that it seeks to protect the interest of large industrial users whose usage requirements are different than the general public. MIEC took no position on the current case.

On September 17, 2018, the Missouri Division of Energy ("DE") filed an application to intervene. DE is a state agency charged with planning for future energy

needs and energy resource development. DE has an interest that is different from that of the general public in that it seeks to plan for the development of the energy industry. DE took no position on the current case.

Also on September 17, 2018, Renew Missouri Advocates d/b/a Renew Missouri ("Renew Missouri") filed an application to intervene. Renew Missouri is a non-profit corporation focused on renewable energy and energy efficiency. Renew Missouri has an interest that is different from that of the general public in that it advocates for renewable energy sources and energy efficiency. Renew Missouri took no position on the current case.

More than ten days has passed since the above listed three applications to intervene were filed and there has been no response. The Commission has reviewed the applications to intervene and finds that MIEC, DE, and Renew Missouri are proper parties and the interventions are granted.

THE COMMISSION ORDERS THAT:

1. The Missouri Industrial Energy Consumers, Missouri Division of Energy, and Renew Missouri Advocates d/b/a Renew Missouri are made parties to this case.

2. This order shall be effective when issued.
