ORDER EXTENDING TIME FILING DEADLINES

On June 10, 2022, the Commission directed its Staff to file a recommendation and that any other responses to the revised tariff, Tracking No. JE-2022-0329, be filed no later than June 21, 2022. On June 20, 2022, Union Electric Company d/b/a Ameren Missouri extended the effective date of its revised tariff filing via the Commission's electronic filing and information system (EFIS). The effective date was extended from July 9, 2022, to August 9, 2022, to allow Staff additional time to review the tariff revision. The Commission will extend the date for the filing of Staff's recommendation and any other tariff responses for one month.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding the compliance tariff sheets, Tracking No. JE-2022-0274, no later than July 21, 2022.
2. Any other responses to the compliance tariff sheets, Tracking No. JE-2022-0274, shall be filed no later than July 21, 2022.
3. This order is effective when issued.
