**MOTION FOR LEAVE TO AMEND APPLICATION**

Comes now Tele-Reconnect, Inc.. ("Tele-Reconnect, Inc." or "Applicant"), by its undersigned counsel, and hereby moves for leave to amend its Application for Certificate of Service Authority filed herein on August 8, 2003, pursuant to 4 CSR 240-2.080(20). In support of this Motion for Leave to File Amendment, Tele-Reconnect, Inc. states:

1. In the Application filed herein on August 8, 2003, Applicant sought authority to provide basic local telecommunications service in the area currently served by ALLTEL, Missouri, Inc. (ALLTEL), and other incumbent local exchange carriers (ILECs). ALLTEL is categorized as a small ILEC, and certain language which is required for applications seeking authority to provide service in the service territory of a small ILEC was inadvertently omitted from the Application.

2. It has been more than 10 days since the Application was filed; hence, by Commission rule (4 CSR-240-2.080(20)), leave of the Commission is required to amend the Application. Tele-Reconnect, Inc. hereby requests leave to amend it Application by adding the following language to the Application as new paragraphs 17 and 18:

17. In any area served by a small ILEC, Applicant agrees to offer telecommunications services defined by the Commission as essential to qualify for state universal service fund support (essential services) in 4 CSR 240-31.010(5), pursuant to Section 392.451.1(1).


18. In any area served by a small ILEC, Applicant agrees to advertise the availability of essential services and the charges for those services using media of general distribution in compliance with Section 392.451.1(2) RSMo.

3. In addition, Applicant wishes to advise the Commission that it has adopted the M2A interconnection agreement with Southwestern Bell Telephone Company, and has filed documentation of that adoption with the Commission.

4. Therefore, with the amendment sought herein, Tele-Reconnect, Inc. believes the Commission will have before it all necessary information on which to base an Order approving Tele-Reconnect, Inc.'s Application for basic local exchange authority and Tele-Reconnect, Inc.'s proposed initial basic local service tariff.

WHEREFORE, Applicant Tele-Reconnect, Inc. moves for leave to amend its Application as stated herein and renews its request for the Commission to grant it certificate of service authority to provide basic local telecommunications services, for competitive classification and waivers, and to approve Tele-Reconnect, Inc.'s separately filed initial basic local service tariff.


