INTERCONNECTED VOICE OVER INTERNET PROTOCOL REGISTRATION

On September 1, 2021 CenturyTel Broadband Services, LLC d/b/a CenturyTel (“the Company”) pursuant to Section 392.550, RSMo, filed an application for registration to provide Interconnected Voice over Internet Protocol services in the following exchanges:

Statewide

On September 9, 2021, the Commission filed a Notice of Deficiency due to the application being incomplete. On September 16, 2021, CenturyTel filed an amended application correcting the deficiency. The Commission has reviewed the amended application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

THE COMMISSION ORDERS THAT:

1. CenturyTel is registered to provide Interconnected Voice over Internet Protocol services in the exchanges set forth in the affidavit attached to the application and restated above.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on September 27, 2021.
4. This file may be closed on September 28, 2021.
