ORDER ESTABLISHING TIME TO RESPOND

On March 24, 2023, the Staff of the Commission (Staff) filed a motion advising the Commission to cancel the registration to provide IVolP service of Wireless Investments, LLC at that company's request.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the registration based on Staff's motion and at the company's request.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than April 7, 2023.
2. This order shall be effective when issued.
