STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and files this *Status Report* for the Commission’s information and consideration, respectfully stating the following:

1. On August 7, 2009, dPi Teleconnect, LLC (dPi or Company) filed an *Application For Designation As An Eligible Telecommunications Carrier (Application)*, requesting designation throughout certain AT&T Missouri service territories for the purpose of receiving federal universal service low income support.

2. On March 5, 2010, the Staff filed its *Staff Recommendation (Recommendation)* with attached *Memorandum*, outlining deficiencies found within the *Application*. The Staff has assisted the Company in the attempt to resolve the *Application’s* outstanding deficiencies.

3. Subsequent to the Staff’s filing of the *Recommendation*, dPi submitted a *Response*, tariff, and corrections to the Company’s 2007 and 2008 Annual Report (AR) deficiencies.

4. On April 19, 2010, the Staff requested until May 17, 2010, to review the Company’s *Response* and anticipated responses thereafter. As the Company has only recently filed a tariff for the low income services it intends to offer, and is in the process of supplementing some deficiencies further, the Staff respectfully requests additional time to review the Company’s filings.

5. dPi's submitted tariff, tracking number JC-2010-0602, has an effective date of June 9, 2010. As such, the Staff suggests it is appropriate to file an updated recommendation on the Company's *Application*, as supplemented, concurrent with a recommendation on the tariff no later than June 1, 2010.

WHEREFORE, the Staff respectfully requests that the Commission issue an order allowing the Staff until June 1, 2010, to file an updated recommendation on dPi Teleconnect, LLC's *Application* and a recommendation on the tariff.
