

1. On June 22, 2004 the Commission issued its *Order and Notice* in this matter. Pursuant to that order, a prehearing conference was held in this matter on July 15, 2004. All parties have jointly agreed upon the following dates for recommendation to the Commission:

Applicants file Direct Testimony: July 30, 2004

Staff and OPC file Rebuttal Testimony: August 13, 2004

Filing of List of Issues, Statements of
Positions, Order of Opening
Statements, Order of Witnesses and
Order of Cross-Examination: August 27, 2004

Evidentiary Hearing: September 3, 2004 at 10:00 a.m.

2. The parties are not proposing a date for the filing of surrebuttal testimony because presently it is not anticipated that there will be any issues among the parties. Nonetheless, if any issues arise, the parties believe that there is likely adequate time between the filing of rebuttal testimony and the date of the evidentiary hearing to

accommodate the filing of surrebuttal testimony, and regardless, if there are any issues, they are more likely to involve questions of law rather than questions of fact.

WHEREFORE, Applicants and Staff hereby pray that the Commission grant their Motion for Establishment of Procedural Schedule.




