
## NOTICE OF DEFICIENCY

On December 15, 2017, Premiere Conferencing Networks, Inc., filed an application for registration to provide interconnected voice over internet protocol service. Premiere's application was not complete in that the affidavit attached to the application failed to provide the exchanges in which the company proposes to provide VoIP service, as required by section 392.550.3(2), RSMo.

The Commission will not take action on this application until this deficiency is corrected. The Commission will leave the file open until January 10, 2018, to allow Premiere to correct the deficiency. If no response is filed by that time, the Commission will reject the application and close the file.
