ADDENDUM TO WATER SERVICE AREA TERRITORIAL AGREEMENT

COMES NOW Public Water Supply District No. 1 of Ralls County, Missouri ("Ralls"), by and through counsel, and pursuant to Section 247.172 RSMo., 4 CSR 240-3.625, and Paragraph 6 of the Water Service Area Territorial Agreement between Ralls and the City of Hannibal, Missouri ("Territorial Agreement"), approved by the Commission on January 7, 2005, submits this Addendum to the Territorial Agreement.

- 1. On January 7, 2005, the Commission issued its Report and Order in Case No. WO-2005-0127 approving the Territorial Agreement. On two occasions since that date; namely, December 15, 2005, and September 25, 2006, the Commission issued its Report & Order Approving Addendum to Interconnection Agreement in the same docket.
- 2. Ralls and the City of Hannibal, Missouri, have reached agreement on a further addendum to the Territorial Agreement. This agreement provides for Ralls to provide service to a structure located at # 4 Brook Rd., Hannibal, Missouri 63401.
- 3. Paragraph 6 of the Territorial Agreement addresses the addendum process as follows:

The Parties may agree on a case-by-case basis by an Addendum hereto to allow a structure to receive service from one party although the structure is located in the service area of the other.

Such Addendum referred to above shall be filed with the Executive Secretary of the Missouri Public Service Commission in the same manner as a motion or other pleading, with a copy submitted to the Office of the Public Counsel.

Each Addendum shall consist of a notarized statement identifying the structure, the party to serve the structure and the justification for the addendum and indicating that the parties support the Addendum.

Each Addendum shall be accompanied by a notarized statement, signed by the customer to be served which acknowledges such customer's receipt of notice of the contemplated service to be provided and that the Addendum represents an exception to the territorial boundaries approved by the Public Service Commission and shall indicate the customer's consent to be served by the Party contemplated by the Addendum.

If the Staff of the Public Service Commission or Office of Public Counsel do not submit a pleading objecting to the Addendum within fortyfive (45) days of the filing thereof, the Addendum shall be deemed approved by the aforesaid parties. However, if a pleading in opposition to the Addendum is filed by the above listed parties, the Commission shall schedule an evidentiary hearing at the earliest reasonable opportunity to determine whether the Addendum should be approved. Each Addendum shall contain a statement in bold uppercase typeface indicating that the Staff or Office of Public Counsel has forty-five (45) days to oppose the Addendum or else the Addendum shall be deemed approved by the aforesaid parties.

Each party, pursuant to an executed Addendum, shall have the right to provide temporary service until the Commission approves or disapproves the Addendum. No party shall be required to remove any facilities installed pursuant to an Addendum until the effective date of an Order of the Commission or a court regarding the removal of same.

5. Pursuant to Paragraph 6 of the Territorial Agreement:

THE STAFF OR OFFICE OF PUBLIC COUNSEL HAS FORTY-FIVE (45) DAYS TO OPPOSE THE ADDENDUM OR ELSE THE ADDENDUM SHALL BE DEEMED APPROVED BY THE AFORESAID PARTIES.

6. Shelby E. Terrill and Kassondra S. Terrill, husband and wife, ("the customer") own property located at #4 Brook Rd., Hannibal, Missouri 63401 ("the site"). Under the terms of the territorial agreement, the Terrill property lies within the water service area of the City of Hannibal. Hannibal does not currently have water lines in place to serve the site. In order to provide water service to the site, a new water line would have to be installed. Ralls, however, does have existing facilities in place nearby which can serve the site without the additional cost to the customer.

- 7. The customer has requested that Ralls provide service to the site and both Ralls and Hannibal consent to the request and support the filing and Commission approval of this Addendum to the Territorial Agreement, as reflected in the Verifications of this Addendum attached hereto and incorporated herein.
- 8. A notarized customer consent, executed by Shelby E. Terrill and Kassondra S. Terrill is attached to this Addendum and incorporated herein.
- 9. Shelby E. Terrill and Kassondra S. Terrill, Public Water Supply District No. 1 of Ralls County, Missouri, and the City of Hannibal recognize that this Addendum represents an exception to the water service territorial boundaries approved by the Commission in Case No. WO-2005-0127, and that once effective, this Addendum will allow Ralls to continue to provide water service to aforementioned structure unless and

until the Commission, upon proper petition, would authorize a change of water supplier in a subsequent proceeding brought for that purpose.

WHEREFORE, Public Water Supply District No. 1 of Ralls County, Missouri, respectfully submits this Addendum to the Territorial Agreement approved in Case No. WO-2005-0127, and requests the Addendum be approved by the Commission.
