NOTICE OF DISMISSAL

Issue Date: October 19, 2021

On August 27, 2021, Complainant, Linda McElwee, filed a complaint with the Missouri Public Service Commission against Grain Belt Express, LLC. The Commission issued notice and directed its Staff (Staff) to file a recommendation. Staff filed a response and a motion to dismiss count II of the complaint.

On October 16, 2021, Complainant filed a *Voluntary Dismissal of Complaint* asking the Commission to dismiss her complaint. Commission Rule 20 CSR 4240-2.116(1) states that a party may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence has been offered.
