**ORDER SETTING TIME FOR RESPONSES TO MOTION TO DISMISS**

Issue Date: March 1, 2022 Effective Date: March 1, 2022

On December 20, 2021, Delmar Gardens Enterprises, Inc. filed a complaint against Union Electric Company d/b/a Ameren Missouri. On February 7, 2022, Ameren Missouri filed its answer and a motion to dismiss.

Pursuant to Commission Rule 20 CSR 2.080(13), parties are allowed ten days to answer pleadings, unless otherwise ordered by the Commission. The Commission will use its discretion under this rule and will order a timeline greater than ten days for the parties to file responses to Ameren Missouri’s motion to dismiss.

**THE COMMISSION ORDERS THAT:**

1. Any party that desires to respond to Ameren Missouri’s motion to dismiss shall do so on or before March 14, 2022. No parties are required to respond.
