**ORDER GRANTING EXTENSION**

Effective Date: May 12, 2023

On March 7, 2023, Charles A. Harter filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. On April 27, the Commission issued an order directing the parties to file a joint proposed procedural schedule no later than May 15, 2023. On May 12, 2023, the Staff of the Commission (Staff) filed a motion explaining that many details remain unsettled between the parties, and requesting that the Commission extend the time to file a joint proposed procedural schedule up to and including May 22, 2023.

The Commission finds Staff’s request to be reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Staff’s motion for extension of time to file a joint proposed procedural schedule is granted.
2. Staff shall file a joint proposed procedural schedule no later than May 23, 2023.

3. This order shall be effective when issued.
