MOTION FOR LEAVE TO AMEND APPLICATION

NOW COMES Now Acquisition Corporation ("NAC" or "Applicant"), by and through its undersigned counsel, and hereby moves for leave to amend its Application for Certificate of Service Authority filed herein on July 25, 2003, pursuant to 4 CSR 240-2.080(20). In support of this Motion for Leave to Amend, Applicant states as follows:

- 1. Applicant NAC plans to provide basic local exchange service under the certificate requested in this case not only on a "resale" basis, but also on a UNE-P basis. Therefore, NAC hereby requests leave to amend its Application in this case by simply deleting the word "resale" or "resold," or any other reference to service being provided on that basis, wherever such word or reference appears in the Application. NAC further requests leave to amend its Application by changing the reference to "resale agreements" in the last line of paragraph numbered 3, to "interconnection agreements."
- The words "resale" and "resold" do not appear in the style of the case, nor do they appear in the description of authority sought in this case in the "Notice of Applications" published by the Commission on July 29, 2003. Likewise, orders issued by the Commission granting certificate

of service authority to provide basic local telecommunications services in Missouri do not designate whether such service is to be "resold," or "facilities-based" (including UNE-P). Therefore, this amendment should not affect the legal efficacy of the notice previously published by the Commission in this case.

3. NAC desires to proceed with the instant Application, and related applications for approval of a transfer of assets (Case No. XM-2004-0065) and for an interexchange certificate of service authority (Case No. XA-2004-0066), as expeditiously as possible. The transfer transaction is being overseen by the federal Bankrutpcy Court. NAC prays this Motion for Leave to Amend will not hinder the Commission's expeditious processing of these cases, and gratefully acknowledges the Commission's and Staff's patience and accommodation of NAC to date.

WHEREFORE, Applicant NOW ACQUISITION CORPORATION respectfully requests leave of the Commission to amend its Application in this case as described above, and requests that the Commission grant it a certificate of service authority to provide basic local telecommunications service as herein requested, classify Applicant and its proposed services as competitive, grant waivers of the statutes and regulations delineated in the Application, and approve its proposed tariffs.
