On June 14, 2022, pursuant to 20 CSR 4240-28.011(2), Northeast Missouri Rural Telephone Company submitted a letter advising that it had adopted "NEMR" as a fictitious name. On July 8, 2022, the Commission's Staff filed a recommendation indicating that the company has complied with all regulatory requirements for the name change. Staff recommends the Commission recognize the name change. The Commission will do so.
