## SECTION 8.0 - SPECIAL ARRANGEMENTS, CONT'D

### 8.3 Independence Plan Volume Discounts – Two Year Term Promotion

Please refer to Section 2.12 of this tariff for one-year term commitments for the Independence Discount Pricing Plan. The Company is offering a promotional two-year term commitment for any Missouri customer who would like to subscribe. Discounts for a two-year term commitment are noted below. This promotional offering is valid from September 20, 2002 through December 20, 2002.

The length of the term commitment determines the retroactive (per invoice cycle) volume discount schedule. Total contributory services under the Customer Master Account Level are to be aggregated during the billing cycle, to determine the earned discount percentage. The earned discount percentage will be applied to all eligible billing to determine The Independence Plan Volume Discounts earned. Product discounts are determined after feature discounts are applied.
