**JOINT MOTION FOR PREHEARING CONFERENCE**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and on its behalf, and that of Harold and Debbie Meyer (“Applicants”), and the counsel for the City of Marceline (“Marceline”), known collectively as the participating parties<sup>1</sup>, files this *Joint Motion* with the Missouri Public Service Commission (“Commission”) respectfully stating the following:

1. On August 4, 2009, the Applicants filed an *Application For Change Of Electric Service Provider* (“*Application*”) to allow a change of supplier from Marceline to Macon Electric Cooperative (MEC). The Applicants assert poor service as the reason for the *Application*.
2. In response to the Commission’s *Notice of Ex Parte Contact And Order Directing Filing*, the participating parties propose April 29, 2010, at 10 a.m., for the Commission to convene a second prehearing conference. To date, no conflicts appear on the Commission’s calendar.
3. The participating parties request that the Commission allow appearances for the prehearing conference by telephone

<sup>1</sup> Counsel for the Staff contacted Mr. Wayne Hackman, General Manager of Macon Electric Cooperative (MEC), regarding the Commission’s *Notice of Ex Parte Contact And Order Directing Filing*. MEC states that while it does not intend to play an active role in this case, it will continue to monitor its progress. For the Staff’s November 20, 2009 filing setting the first prehearing conference, the Office of Public Counsel (OPC) indicated at that time it did not plan to participate in any scheduled prehearing conference.

4. Along with the issues of the case, the parties intend to discuss a procedural schedule at the prehearing conference, and shortly thereafter present a procedural schedule to the Commission for approval.

**WHEREFORE**, the Staff, on behalf of the participating parties, submits this *Joint Motion* requesting that the Commission set a prehearing conference in this matter for April 29, 2010, at 10 a.m.
