ORDER EXTENDING DEADLINE FOR STAFF RECOMMENDATION

Issue Date: October 15, 2018 Effective Date: October 15, 2018

On September 11, 2018, Kansas City Power & Light Company ("Company") requested authority to issue General Mortgage Bonds up to \$1,900,000,000 principal amount during the period ending December 31, 2019, which will take the form of six secured senior debt issuances with fixed interest rates equal to the current rate of interest on each series of corresponding underlying Senior Notes. The Company asked for authority to take all necessary actions and to execute all necessary documents for the issuance of the General Mortgage Bonds. The Company also asked that the order granting its application go into effect on November 30, 2018. On September 12, 2018, the Commission directed the Staff of the Commission ("Staff") to file a recommendation on the Company's application no later than October 12, 2018.

On October 12, 2018, the Staff filed a Request for Additional Time to File Recommendation and asked that the deadline be extended to November 2, 2018. Staff stated that it needed additional time to properly review and analyze responses to all of its Data Requests. Staff stated that it has received responses to all of its Data Requests and that assuming that Staff does not need to conduct further discovery, Staff will be able to file its recommendation by November 2, 2018. Staff stated that the Company does not object

to Staff's request that the deadline be extended to November 2, 2018. The Commission will extend the deadline for Staff to file its recommendation to no later than November 2, 2018.

THE COMMISSION ORDERS THAT:

- 1. No later than November 2, 2018, the Staff of the Commission shall file a recommendation regarding the application of Kansas City Power & Light Company to issue General Mortgage Bonds up to \$1,900,000,000 during the period ending December 31, 2019.
 - 2. This order shall be effective when issued.
