Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy) attached a draft financing order to the direct testimony of witness Steffen Lunde. Both in prefiled surrebuttal testimony and in testimony offered during the evidentiary hearing Evergy indicated that it had changed its position concerning some of the parties disputed issues. Accordingly, the Commission will direct its Evergy to file an updated draft financing order that more accurately reflects its current positions with its initial brief on August 31, 2022.

THE COMMISSION ORDERS THAT:

1. Evergy shall submit an updated draft financing order with its initial brief.
2. This order is effective when issued.
