JOINT STATUS REPORT

COMES NOW Spire Missouri Inc., d/b/a Spire (“Spire” or “Company”) and the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, file this Joint Status Report and in support thereof state as follows:

1. On May 10, 2021, the Commission conducted an on the record procedural conference with all of the parties in this case participating. The Judge granted the parties approximately two weeks to determine if a solution could be reached amicably or if a procedural schedule would be necessary.

2. On May 25, 2021, Staff and Spire filed a Joint Status Report informing the Commission that the attorneys have been in contact and requested two weeks to provide a status update to the Commission.

3. On May 26, 2021, the Commission issued an order granting the parties an additional two weeks until June 7, 2021 to file a proposed procedural schedule, status report or other pleading to determine if a solution could be reached.

4. The parties have continued to discuss the matter since that time and continue to be hopeful that a settlement may be possible in this matter. In compliance with the May 26 order, the parties are filing this status report to request an additional two weeks to discuss this possibility of

resolving this case prior to filing a proposed resolution, status update, or a procedural schedule on or before June 21, 2021.

WHEREFORE, the Parties hereby request the Commission grant additional time until June 21, 2021 to file a proposed procedural schedule or an alternative resolution to this matter with the Commission.
