On July 17, 2012, the Missouri Public Service Commission (Commission) issued its Order Granting Certificate of Convenience and Necessity (Order) in Case No. GA-2012-0285, the Summit Natural Gas of Missouri, Inc. (SNGMO or Company) Application for Certificate of Convenience and Necessity (CCN). This Order approved a new and expanded service area for SNGMO.

On August 16, 2012, the Company filed tariff sheets to comply with the Order. On August 29, 2012 and September 4, 2012, SNGMO filed Substitute Tariff Sheets. Subsequent to those filings, SNGMO filed on September 11, 2012, a Second Substitute Tariff Sheet for changes suggested by the Energy Unit – Tariffs/Rate Design Staff (Staff).

The Staff has reviewed the tariff sheets filed by SNGMO on August 16, 2012, and as substituted on August 29, 2012, September 4, 2012, and September 11, 2012, respectively, and is of the opinion that these sheets are in compliance with the Commission's Order.

Staff has verified that SNGMO has filed its annual report and is not delinquent on any assessment. Therefore, Staff recommends the following tariff sheets, filed on August 16, 2012, and as substituted on August 29, 2012, and September 4, 2012, and on September 11, 2012, with an effective date of September 15, 2012, be approved:
