On May 23, 2023,<sup>1</sup> Brett Felber filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. On May 25, Mr. Felber filed his *Emergency Petition* seeking restoration of electrical services immediately.
