- 1 PROCEEDINGS
- JUDGE LANE: Good morning, ladies and
- 3 gentlemen. My name is Benjamin Lane. I'm the Regulatory
- 4 Law Judge who will be conducting the hearing in this
- 5 matter. This is Case No. EC-2007-0146, in the matter of
- 6 Cheryl L. Fabulae, the Complainant vs. Kansas City Power &
- 7 Light Company, Respondent.
- 8 I know you have -- several of the parties
- 9 that are here, that are present here in this hearing room
- 10 have already submitted written entries of appearance, but
- 11 if you would please provide oral entries for the record.
- 12 Staff, please.
- 13 MR. THOMPSON: Good morning, your Honor.
- 14 Let the record show Kevin A. Thompson for the Staff of the
- 15 Missouri Public Service Commission, Post Office Box 360,
- 16 Jefferson City, Missouri 65102.
- JUDGE LANE: Thank you, Mr. Thompson.
- 18 KCP&L?
- MR. BLANC: Good morning. My name is
- 20 Curtis Blanc. I'm here on behalf of Kansas City Power &
- 21 Light. I provided my contact information to the court
- 22 reporter. Thank you.
- JUDGE LANE: Thank you very much,
- 24 Mr. Blanc.
- 25 I want to also state who is not present at

- 1 this hearing. There is no representative of the Office of
- 2 the Public Counsel, which has not participated in this
- 3 proceeding to date. We also do not -- I have the
- 4 Complainant, Ms. Fabulae -- wait.
- Just for the record, we are waiting to see
- 6 if anyone is actually present in the hearing room
- 7 established in Kansas City for this matter. It appears
- 8 from the video link that we saw the elbow of someone in
- 9 the picture. Sound is enabled from that side. Can anyone
- 10 hear me in Conference Room G8 in Kansas City? Is there
- 11 anyone there? Well, is there anyone there? If you would,
- 12 please just indicate by saying that someone is present.
- 13 (No response.)
- 14 JUDGE LANE: Well, perhaps we can give them
- 15 another minute or two just to make sure. We did see an
- 16 individual.
- 17 Let me go ahead and just say, at this
- 18 point, which is approximately 9:05 on Friday, February the
- 19 9th, which is the appointed date of the hearing, there
- 20 does not appear to be any appearance for the Complainant
- 21 in this matter, Cheryl Fabulae.
- 22 Also wish to state for the record that all
- 23 parties were given the opportunity to participate in this
- 24 evidentiary hearing by one of three means. First of all
- 25 would be presence here in Room 310 in Jefferson City, the

- 1 Commission's main hearing room. The second method was by
- 2 video conference link to Office No. G8 in the Fletcher
- 3 Daniel State Office Building in Kansas City where the
- 4 Commission has offices. And the third means was to
- 5 participate by telephone, in which case the party wishing
- 6 to use that method was to have notified me no later than
- 7 January 31st, 2007. I received no such request from
- 8 anyone for participation by telephone.
- 9 The Commission's Order of January 18th also
- 10 specified that any party wishing to seek a continuance of
- 11 the hearing date was to file a pleading with the
- 12 Commission stating why they were unable to attend the
- 13 hearing as scheduled either in person, by video conference
- or by phone, and was to serve a copy of the request on
- 15 every party to the case.
- Sir? This is a little difficult, but we
- 17 did appear to see an individual on the other end. Anyhow,
- 18 this could go on all day, so we'll just continue.
- 19 No such request for continuance was filed
- 20 in EFIS or received by me prior to the hearing date this
- 21 morning.
- Normally I would take up preliminary
- 23 matters and any pending motions. There are no pending
- 24 motions at this time. What is even more preliminary than
- 25 matters of designation of the confidentiality of the

- 1 evidence and so forth is ensuring that we have two sides,
- 2 the complainant and respondent. At this point it appears
- 3 we do not.
- 4 At this point, absent any response from the
- 5 other end or any indication that Ms. Fabulae or a
- 6 representative of her is present at the Kansas City
- 7 location, I would like to entertain some suggestions or
- 8 arguments by the parties who are present as to the
- 9 suggested course of action on a going-forward basis.
- 10 MR. THOMPSON: Your Honor, Staff moves that
- 11 this matter be dismissed for failure to prosecute.
- JUDGE LANE: Thank you, Mr. Thompson.
- 13 Mr. Blanc?
- MR. BLANC: KCPL so moves as well.
- 15 JUDGE LANE: Very well. I will not make a
- 16 ruling at this particular moment, but being as we cannot
- 17 continue under the present circumstances, I think I'm
- 18 going to have to adjourn this matter, and an Order will be
- 19 forthcoming regarding the disposition of this case on a
- 20 going-forward basis.
- 21 At this time we'll go off the record.
- 22 Thank you very much.
- 23 WHEREUPON, the hearing of this case was
- 24 adjourned.
