ORDER APPROVING FUEL ADJUSTMENT CLAUSE TRUE-UP

Issue Date: August 24, 2022

Effective Date: September 23, 2022

Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a request for approval of a true-up amount related to the company's fuel adjustment clause (FAC), as provided by Commission Rule 20 CSR 4240-20.090(9). The true-up filing concerns billing months March 2021 through February 2022, which are designated Recovery Period 27 (RP27). Evergy Missouri West's filing indicates during that period it under-collected \$351,155 from customers.

On July 28, 2022, the Staff of the Commission (Staff) recommended the Commission approve Evergy Missouri West's true-up filing amount of \$351,155 in under-collected costs for RP27. Staff noted that the true-up amount for RP27 is used in the calculation of the Fuel and Purchased Power amount included in Evergy Missouri West's Accumulation Period 30 adjustment filing in File No. ER-2023-0011. Staff noted that, in the adjustment filing in File No. ER-2023-0011, Evergy Missouri West has requested to defer until its next general rate case extraordinary costs related to the February 2021 Winter Storm Uri and also requested to defer this under-collection of \$351,155.

The Commission finds that, while the true-up amount for RP27 is a component of the tariff sheet proposed in File No. ER-2023-0011, approval of the true-up amount neither constitutes nor requires approval of Evergy Missouri West's proposed tariff sheet assigned Tracking No. JE-2023-0005. Based on Evergy Missouri West's uncontested filing and Staff's review and recommendation, the Commission concludes that Evergy Missouri West's true-up amount should be approved. The tariff sheet will be addressed by proceedings in File No. ER-2023-0011.

THE COMMISSION ORDERS THAT:

1. Evergy Missouri West's true-up amount for Recovery Period 27 is approved.
2. This order does not approve a tariff sheet.
3. This order shall be effective on September 23, 2022.
