STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEET AS IN COMPLIANCE WITH COMMISSION ORDER

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), by and through counsel, and for its recommendation to approve the compliance tariff sheet filed on July 2, 2013, by Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") in this matter respectfully states:

- 1. On June 26, 2013, the Commission issued its *Order Granting Variance* in this matter. The order granted Ameren Missouri's request for a variance from the Commission's rules regarding promotional practices¹ and from the Company's tariff rule² regarding the cost of underground service. The variance allows Ameren Missouri to waive certain charges to the developers of Markway Meadows subdivision in Cole County, Missouri, pursuant to the Company's tariff rule regarding unregulated competition.³
- 2. On July 2, Ameren Missouri filed a revised tariff sheet⁴ to reflect the order, along with a motion requesting that the Commission approve the tariff sheet to take

effect on less than 30 days' notice, pursuant to § 393.140(11) RSMo.⁵ The tariff sheet contains a list of the areas, individuals and/or subdivisions that have received Commission-approved unregulated competition waivers; the sheet filed July 2 adds "Markway Meadows Subdivision in Cole County" to the list and refers to this file number (EE-2013-0511).

- 3. The tariff sheet bears an effective date of August 1, 2013, but Ameren Missouri requests the Commission approve the tariff sheet so that it takes effect on July 5, 2013. In support of its motion, Ameren Missouri states that, pursuant to § 393.140(11), good cause exists to make the Company's compliance tariff sheet effective on less than 30 days' notice because the Commission has already granted the Company's request for the variance and expedited treatment, and because the tariff sheet simply memorializes the existence of the variance, as contemplated by Ameren Missouri's tariff.
- 4. Staff has reviewed the tariff sheet and finds that it complies with the Commission's June 26 order. Staff's *Memorandum*, attached hereto as Appendix A and incorporated herein by reference, recommends the Commission approve Ameren Missouri's request to approve the tariff sheet so that it takes effect on July 5, 2013.
- 5. The Staff has verified that Ameren Missouri has filed its annual report and is not delinquent on any assessment. Staff is not aware of any other matter before the Commission that affects or is affected by this filing.
