STAFF RECOMMENDATION TO APPROVE TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through undersigned counsel, and for its *Staff Recommendation to Approve Tariff*Sheet respectfully states:

- 1. On January 26, 2021, Evergy Missouri Metro submitted tariff revisions, Tariff No. JE-2021-0144, bearing an effective date of February 25, 2021, and containing revisions to Evergy Missouri Metro's tariffs for standardized rates for facilities at or under 100 kilowatts design capacity. Commission Rule 20 CSR 4240-3.155(3) requires these tariff revisions to be filed no later than January 15 of every odd-numbered year, and Evergy Missouri Metro filed an application with the Commission requesting the Commission grant it a waiver of 20 CSR 4240-3.155(3), and further requested the Commission approve its tariff revisions.
- 2. The Commission issued an order on January 28, 2021, setting a deadline of February 3, 2021, for persons wishing to file applications to intervene in this matter, and also directing Staff to file a recommendation about Evergy Missouri Metro's application for waiver and tariff sheets no later than February 5, 2021. No person filed an application to intervene in this matter.
- 3. On February 5, 2021, Staff filed a *Motion for Extension* in which it stated that Staff had begun to review Evergy Missouri Metro's tariff filing but Staff needed additional time to continue its review, determine if follow up or discovery was needed, and

ultimately make an informed recommendation on the tariff revisions to the Commission. Staff also stated it had no objection to the Commission granting Evergy Missouri Metro's request for waiver of the January 15 filing deadline in 20 CSR 4240-3.155(3). On February 5, 2021, the Commission issued an order extending Staff' recommendation on the tariff sheets to no later than February 16, 2021, and on February 10, 2021, the Commission issued an order granting Evergy Missouri Metro the waiver it requested.

4. As more fully explained in the attached Memorandum and incorporated herein, Staff has reviewed Evergy Missouri Metro's filing and recommends the Commission approve or permit the following tariff sheet to go into effect for service on and after February 25, 2021:

5. Staff has also verified that Evergy Missouri Metro has filed its most recent annual report.

WHEREFORE, Staff submits its *Staff Recommendation to Approve Tariff Sheet* and corresponding Memorandum and requests the Commission approve or permit the following tariff sheet to go into effect for service on and after February 25, 2021:
